Code and Conduct of the Fayre

All exhibitors / traders are invited and expected to attend the Safety Briefing Meeting on Saturday
14th September at 9.30 am at the Beer Tent

- Exhibitor entries may be limited or restricted according to space. Entries will be accepted at the discretion of the Section Leader with the final decision being made by the Chairmen or Secretary.
- All exhibitors and visitors are asked to share the ethos and vision of the Fayre to raise as much money as is possible for the Salisbury District Hospital Stars Appeal. With no haulage fees paid, no salaries or show appearances paid or offered. Traders and exhibitors are asked to pay for their pitches promptly, and those exhibiting and also selling their wares (Rural Crafts particularly) are asked to contribute a percentage of their takings to the charity fund.
- I declare that during the whole period of the Berwick St John Country Fayre, my entry will be covered by Public Liability Insurance, which includes rally use, and where necessary by a Boiler Explosion Policy, having a limit of indemnity of not less than £5,000,000
- I further declare that in case of any event taking place wholly or partly on the Public Highway, that the vehicles hereby entered are covered by insurance as requested by the Road Traffic Act 1960, which is valid for such part of this event which will take place on such roads defined in that Act.
- I further declare that I will produce the necessary Hygiene Certificates, Food Hygiene Rating and that all electrical equipment is PAT rested. A HACCP assessment must also be produced by the business for inspection before participating in the Berwick St John Country Fayre.
- I confirm that if cooking I will supply my own fire extinguisher/fire blanket.
- I confirm that the driver/s of any vehicles owned by me holds and is not disqualified from holding a licence to drive a vehicle of the appropriate class. No person may drive an exhibit on site unless they have a current driving licence and the vehicle is insured for public liability.
- Understand and agree to comply and follow ALL safety rules.
- I agree to follow and observe Stewards and Section Leaders requests and instructions.
- I adhere to the NO MOVEMENT on SITE between 10am and 5pm on both Saturday and Sunday.
- No alcohol drink to be consumed whilst driving or operating machinery.
- Only alcohol purchased on site may be consumed within the entertainment area of the showground. Any floating of this rule will convene The TENS Licence and the perpetrator will be asked to leave the showground.
- I agree to place all litter in the receptacles provided.
- If you see something you think is not right, is unsafe or dangerous report it to the Safety Officer, Section Leader or Admin IMMEDIATELY.
- I agree to treat those around me, the land we are fortunate enough to be upon and the local community with respect and consideration at all times.
- Arrival of the Showground, exhibitors will be allowed to access the showground from 10am on FRIDAY 13th SEPTEMBER. Passes must be shown. You will be placed in the holding bay if there are any issues on your arrival until your Section Leader, Chairmen or Secretary can resolve the issue. On arrival at your section please report to your Section Leader who will show you where to set up and to camp.
- Entry to the Fayre whether exhibiting or visiting will be at the discretion of the Chairmen and Secretary with the involvement and consultation of the Section Leader and fellow Directors. The Chairmen have the final say. Any disturbances will result in being asked to leave the show field.
